## INTRODUCTION

Transparency and access to public information have become fundamental topics, indissoluble of political and social change in the world.

As corollary of the new democratic wave of the last part of the 20<sup>th</sup> century, both subject matters are compulsory in the political agenda of every nation. This is not merely causal: once the nations consolidate an open regime and agree upon the rules of the game of access to power, typical subject matters of the 'second generation' come up immediately. Then the discussion isn't just access to power but how to exercise and control democratic power. And, in the core of this new dilemma we find transparency and access to information. Such reasons—circumstantial to democratization—have conformed a true international movement in 50 countries that have approved access to information Laws and 30 other that are in a process of adopting legislations in such matter.

This reality deserves a discussion and international position that accompanies the construction process of the involved nations, so that it can promote the incorporation of such themes into the agendas of multilateral organisms (such as IMF, WB, OCED, IDB, amongst others) and sub national governments, around the world.

For these effect, the Third International Conference of Access to Information Commissioners has been called upon. It has been designed as a meeting place for the authorities of the world that have a mission to protect and promote the right of access to information. This is an annual event, which in 2005 will be organized by Mexico through the Federal Institute of Access to Public Information (IFAI, its Spanish acronym), to be taken place in the City of Cancún, in the state of Quintana Roo.

Eleven countries of the world which have analogous institutions are invited, these are: plus the host country. This will be a space of deliberation and debate, a place of crossings and experience interchange between the commissioners of access to the information and personal data protection in the world, and them, along other personalities that come from multilateral and international organisms will show there interest in the subject matter.

The main purpose of the Conference is to recognize and disseminate the power of the right of access to information and its impact on people's life, public deliberation, and the exercise of power. The event will have a double content: on the one hand, an exploration of relevant and meaningful international experiences that have modified inertias, changed corrupt habits and improved the relation between government and citizens. And on the other, the Conference will allow making a call at the sub-national, national and international level, in order to engage all contemporary democracies and multilateral organizations with the disclosure of public information and to promote the incorporation of these topics into their political agenda.

The Third International Conference of Access to Information Commissioners will approach the theme of access to information from society's perspective (as it exercises its right and as it demands accountability from the power structure); from the perspective of the democratic state (committed to create an institutional framework –vertical and horizontal control mechanisms of the action of those who govern— beyond the transparency of the voting system). These objectives are joint also by the perspective of international organisms (that actively promote this principals in the nations and inside themselves).

The coordination of this event in Mexico is a unique and exceptional opportunity for the promotion and dissemination of the Federal Law of Transparency and Access to Government Information, as well as the work developed by the IFAI. This Conference will summon emblematic protagonists, authors and protagonists of the law to access to the information, personalities that due to their trajectory and public or universal relevance, or due to their strategic placing in global institutions, will help us relaunch this call in favor of the transparency and liberty of information in the world.
